Plan now to attend the 2013 Imperial Session in Indianapolis

The 2013 Imperial Session is scheduled for June 30-July 4, in Indianapolis, Indiana. This vibrant city is part of one of the fastest growing metropolitan areas in the United States.

Indianapolis is no stranger to tourism - it hosts numerous conventions and sporting events throughout the year. In February 2012, Indianapolis hosted the Super Bowl for the first time in the city's history. The city will be ready for the Shriners in 2013.

In addition to fast cars, the city is the home of the Indiana War Memorial Plaza. The five-city-block plaza serves as both a memorial to fallen soldiers and a museum chronicling the history of armed forces from the state of Indiana. The plaza also houses the national headquarters of the American Legion.

For those who prefer museums, the Indianapolis Art Museum contains more than 50,000 works of art from a variety of cultures and periods in history. Adjacent to the museum is 40.46 hectares: The Virginia B. Fairbanks Art & Nature Park, the largest contemporary art park in the country.

Outdoor enthusiasts will enjoy the Indianapolis Central Canal in White River State Park. The beautiful 2.5 kilometer long canal offers gondola rides, pedal boats, and rental of all kinds of bicycles.

The city also offers entertaining nightlife. One of the trendiest sections of the downtown area is Broad Ripple Village, which is home to a great selection of notable restaurants, bars and nightclubs.

The Murat Shriners and Deputy Imperial Potentate John Cinotto look forward to hosting the 2013 Imperial Session in their home city. Plan to be there - and be part of the fraternity's most important week of the year.

2017 Session Location Announced

At the 2012 Imperial Session, Daytona Beach, FL, was approved as the host city for the 2017 Session.

Located on the east coast of Central Florida, Daytona Beach offers visitors moderate weather, exceptional recreational activities, an active arts community and, of course, one of the most beautiful, family-friendly beaches anywhere.

Daytona Beach has become a center for motorsports, as it hosts the Daytona 500 and is the headquarters for NASCAR. Although the city is largely known for its speedway and beach, it also offers a wide variety of famous landmarks and cultural centers. These include Jackie Robinson Ballpark, Halifax Harbor Marina, Tarragona Arch, Municipal Stadium, Ocean Center, Peabody Auditorium, the Clock Tower and Bandshell, Museum of Arts and Sciences and the Daytona Beach Pier.

Please also note that the Imperial Session will be held in Minneapolis, Houston and Tampa, FL, in the intervening years.

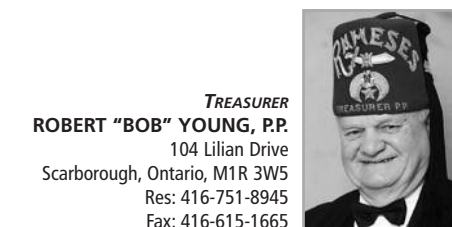

Introducing the 2012-13 Shriners Hospitals for Children Patient Ambassadors

Every year, Shriners Hospitals for Children chooses two patient ambassadors to represent the thousands of children who receive care at the health care system's 22 facilities annually, regardless of the ability to pay. The Ambassadors will share their stories to inspire others and raise awareness of Shriners Hospitals for Children.

Meet Hunter Woodhall and J  r  my Gabriel, the Athlete and the Artist, our 2012-13 Ambassadors. They were introduced after the premiere of the video which tells their stories, "Two Worlds Apart - One Place of Hope," during the public relations presentation at the recent Imperial Session of Shriners International in Charlotte, NC.

The Athlete:

He plays basketball, football and soccer; he wrestles; he runs track, snow skis, swims and roller blades, all with two prosthetic legs.

Hunter Woodhall, 13, was born with fibular hemimelia of the left leg. The condition is a shortening or absence of one of the two bones in the calf, which may require amputation or bone-lengthening procedures to correct. In addition, his right ankle was fused.

The Woodhalls had a difficult time finding information about Hunter's conditions. After exploring options that offered no real hope, the Woodhalls contacted Shriners Hospitals for Children.

After consulting with a team of experts at the Tampa, FL, facility, the Woodhalls proceeded with the amputation of Hunter's feet. After his surgery, at just 11 months old, Hunter was soon walking and running around. He hasn't stopped since.

Later, the Woodhalls moved to Syracuse, Utah, where Hunter became a patient of Shriners Hospitals for Children, Salt Lake City. Hunter is a straight A student and an accomplished athlete.

The team of experts at Shriners Hospitals for Children, Salt Lake City has always provided options to help Hunter be able to do anything he wants to do, including fitting him with some of the first Flex-Foot Cheetah custom feet that the hospital had ever provided, as well as special liners for wrestling, in addition to his prosthetic legs for daily use.

The Artist:

He has sung for both C  line Dion and the Pope; he has recorded two albums and co-authored a book. He was born deaf.

J  r  my Gabriel, 15, of Quebec City, Canada, was born prematurely with severe facial malformations and other complications requiring intensive care.

J  r  my was finally diagnosed at 6 months with Treacher Collins Syndrome, a rare genetic disorder. In addition to head, skull and facial deformities, children with this condition generally have absent or malformed ears, which can cause hearing loss.

J  r  my was referred to Shriners Hospitals for Children - Canada at age 5 for treatment. There, the family met Lucie Lessard, M.D., a plastic and craniofacial surgeon. Dr. Lessard suggested a BAHAs (Bone Anchored Hearing Aid) Implant, which J  r  my received in June 2003, at age 6. After the surgery, J  r  my was fascinated with sound, and discovered he could sing. In fact, he has perfect pitch. J  r  my is scheduled for additional facial reconstructive surgery later this year, including surgery to reconstruct his cheekbones, as well as surgery on his jaw, which should improve his breathing and chewing.

J  r  my now attends a high school specializing in performing arts, where he is an excellent student. He is preparing for a career in the music business.

Shriners Hospitals for Children is proud to have been able to provide expert care to both Hunter and J  r  my, and wishes them every success in the future.

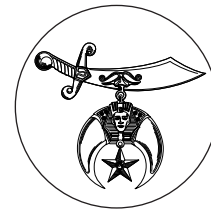

Recorder's Message

Ten days ago as I write this message, we held an Emergent Meeting at 3100 Keele Street to discuss the possible sale of our headquarters and approximately 130 Nobles showed up with a good number of them seeking answers to a fair number of questions.

Most of the questions were well thought out and were presented in a respectful manner. One or two were not and I quote, (1) did we give consideration to the Masonic groups that meet here (or do we care?). Well Nobles, I cared well enough to write to every group in order to keep them informed on what may happen on Saturday, November 17th, 2012 when you, our members, vote on whether to sell this property or not. Please Nobles all note that you will decide the fate of 3100 Keele Street. Your Divan only has (7) seven votes and there are 3,700 of you out there all eligible to vote provided you have a 2012 dues card in your possession. To pass in favour of a sale will require 50% + 1 of those present and voting. Proxy votes are not allowed under Imperial Bylaws.

Let me give you a brief rundown on how and what has happened in the last 12 months (give or take). In mid 2011 it became somewhat obvious that we (Rameses) were going to have a capital short fall at year end and our concerns were confirmed by our financial statement that every member of Rameses received, the amount was \$152,020.00 and that coupled with our loss in 2010 in the amount of \$209,032.00 made for a two year loss in the amount of \$361,052.00, listed on page 4 of your financial statement all numbers approved by our auditors Sloan Group Chartered Accountants.

Your Divan are not all brilliant people and none of us have a Ph.D. or letters after our name however we are trustworthy individuals, all elected by our membership on the basis of trust, sincerity, honour, Masonic principles and if they didn't have these qualities why would you elect them? There isn't a man on this Divan that does not have your best interest at heart and we are simply keeping you all informed so you can make the wise decision on November 17th, 2012.

In 2011 we brought in two real estate groups to evaluate our property. The answer given was between the high \$3 million to the low \$4 million dollars. A third agent showed up, got all excited, brought in his client, took a hundred pictures and I never saw him again. At that point your Divan shelved this information.

In early June of this year, we received an unsolicited offer in cash in the mid \$4 million dollar range to purchase 3100 Keele Street and this offer did get our undivided attention. We did have an agreement with the Scottish Rite on first right of refusal so we contacted them and asked them if they were interested and if so, the building would be theirs. The answer was a very respectful no. We now felt that based on the pressure from the proposed buyer that we needed to bring our real estate expert on board along with our legal department

and we passed over all future dealings to them regarding our conditions that had to be met if a sale was to take place, not the least of which was our obligation to bring our membership on board, knowing full well that no sale can take place without their approval and our continued obligation to keep our tenants in the picture. Note, this has all been done.

Be advised that if this sale is approved in November of 2012, the Lodges, the Scottish Rite and the Rameses Shrine have full use of the building up to December 31st, 2013. That will give us approximately 13 months to get ourselves into a new location of between seven and ten thousand square feet, which is more than enough to provide the basics for our membership.

Our present location 3100 Keele Street is 37,168 square feet which we heat, cool and maintain and it's just way too big for us now that our membership is half of what it used to be.

We intend to rent or buy a new location more than likely buy if the price is what we have in mind. (I'm not printing this number for obvious reasons) and no, we will not be frittering away the surplus money, as one Noble suggested the Scottish Rite did. Frankly Nobles I thought this was a low blow and not at all what I would expect from a Brother Mason. By the way, we were also asked if someone was getting a kickback on this sale. It never ceases to amaze me what my Brothers can come up with.

In any event, we decided to bring in a qualified property assessment expert and after two days of questions and answers, we got a beautiful binder an inch thick with maps and pages of details. The assessed value was \$5,220,000.00. In the meantime a bidding war was taking place between the original purchaser and another broker. They both raised their offer two or three times with the final offer to date being \$6,125,000.00 and that's the one we are dealing with as I write this message. I do think the bidding war has stopped and according to our real estate broker and our lawyer, the purchaser will honour our conditions. The next move is yours and on Saturday, November 17th, 2012 you, our members, decide the road we must travel and I respectfully request a good turn out from you.

I feel compelled to advise you that one Noble suggested that we picked the Fall Ceremonial date because most of those Nobles attending would be from out of town and that they would vote to sell. Nobles nothing could be further from the truth and I will only state that there were only two reasons for the November 17th as follows; (1) we usually get a good turn out of Nobles for this one and (2) the vote on this very important item must be taken at a Stated Meeting and at our headquarters. That's the reason and no other. The Nobles that have strong feelings on this subject for or against, need to show up and vote. Let me repeat what I said before. You, our membership will make the decision. All I ask is that you weigh all the pros and cons then vote for the good of Rameses. Please don't turn this very important item into a personal vendetta. Listen to the facts; consider how they will affect our future not you personally and good luck with your decision.

The Illustrious Potentate will read out the motion to sell at approximately 12:30 p.m. on Saturday, November 17th, 2012.

Dear Fellow Nobles:

At the Annual Meeting of 2009, a very historic vote took place. Our membership authorized Shriners Hospitals for Children to move forward with a Revenue Cycle Initiative. That collective decision ensured that children in need will continue to receive Shriners specialized care for many more years. Please be assured that this initiative is not changing Shriners' commitment and mission at all.

Shriners Hospitals now have contracts with many insurance companies and state healthcare programs. This is requiring us to comply with numerous laws and regulations. As a result, we must be very careful that we no longer promote Shriners Hospitals as providing "free care".

That phrase "free care" or "care without cost" does not really accurately reflect the significant contributions made that are made every day by our Fraternity and by our generous Donors that support the expert care we provide. It is truly "more accurate" to say "that Shriners Hospitals provide the highest quality medical care to children - regardless of the patient's or family's ability to pay". We all need to encourage our Nobles to utilize this newer phrase, which is also a part of our mission statement.

Unfortunately, those phrases such as "free care" and "care at no cost" are red flags to our insurance providers and the regulatory agencies. They reflect practices that contradict our Shriner's "contractual obligations" with the insurers.

It therefore becomes very important for all of us to promptly review our documents, our newsletters and our other publications at your Shrine Center and change those that contain these statements. We will also need to eliminate these phrases from our web-sites.

In addition, these phrases that are on our Shrine Center vans, parade vehicles, and anywhere they might be displayed in our buildings, should also be removed. It will serve our philanthropy much better to use this newer phrase from our "Mission statement", "Regardless of our patient's or family's ability to pay".

So that we have no further "awkward discussions" with the insurance providers or regulators, all of the members of your National Boards, hope that you will be able to make these changes at your facility, as quickly as possible.

This action on your part is extremely crucial to the continuing success of our Revenue Cycle program. Once we are past this issue, our historical action of 2009 will help Shriners International sustain our charitable mission well into the future. Each of us appreciate all that you do on a daily basis to support our fraternity and our hospitals.

Please help us spread the word to all of our Nobles and their Ladies, that our new Shriners' Slogan is: "All care at Shriners Hospitals for Children is provided without regard to a patient or family's ability to pay."

Special Notice

As revised 2012 Imperial Bylaws

§ 325.11 Election Regulations.

(a) **Electioneering.** A candidate for an elected office in a Shrine temple may print, publish and circulate during the year he is seeking the elected office, a resume consisting of his educational background, his vocational history, and his Masonic and Shrine record. Except as provided in the prior sentence, the printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a unit, club, Noble, or group of Nobles, suggesting, recommending, opposing, or containing the names of proposed candidates for office in the temple is prohibited.

(b) **Expenditures Prohibited.** The expenditure of money for gifts, favors, or entertainment on behalf of a candidate for elected office is prohibited.

(c) **Violation.** For any violation of (a) or (b), the Imperial Potentate may suspend any offending Noble, and he may declare the election of the officers void and order a new election.

(d) **Notice.** At least one week prior to the annual meeting or any election, the temple Recorder shall mail to each member a notice thereof containing this section.

Amend. 2011

§ 325.12 **Postponed Election.** If it is impossible to hold the election as required, or if it appears to the Imperial Potentate proper, he may grant a special dispensation changing the date of the annual election.

§ 325.13 **Vacancies.** An office becomes vacant in the event an officer or Representative dies, resigns, is suspended, is expelled, is adjudged mentally incompetent, is physically incompetent, is convicted of a felony or of any criminal offense involving moral turpitude.

§ 325.14 Filling Vacancies in General.

(a) **Special Election.** A special election may be held without a dispensation to fill a vacancy in elective office; and if the vacancy occurs before July 1, a special election to fill it shall be held within sixty days after it occurs, unless a special dispensation for a later election is granted by the Imperial Potentate.

Amend. 1980

(b) **Advancement.** Any vacancy that may occur by the promotion of any officer at any special election may also be filled at that election.

(c) **Appointive Office.** Vacancies in appointive office shall be filled by the Potentate.

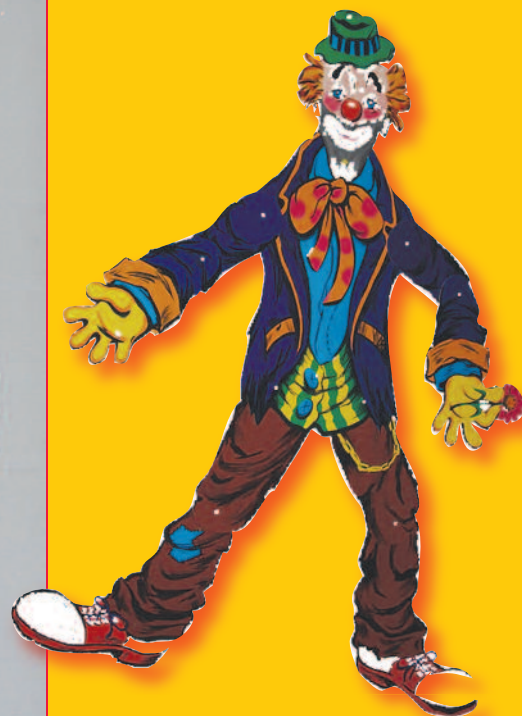
(d) **Declining.** A Noble cannot be compelled to accept an election or appointment to office.

§ 325.15 Filling Vacancies in Particular Offices.

(a) **Representative.** If the vacancy is in the office of an elected Representative, and time is not sufficient to call a special election, the Potentate shall appoint a Representative, and notice of the appointment, by letter or fax, must reach the Imperial Recorder's office before 9:00 a.m. on the 5th day preceding the opening of the next Imperial Session of Shriners International, in order to qualify the Representative.

(b) **Treasurer or Recorder.** If the vacancy is in the office of Treasurer or Recorder and results from any of the causes stated in § 325.13, the Potentate shall appoint a member to fill the vacancy until a successor has been elected and installed.

§ 325.16 **Report of Election.** The result of any election shall be reported forthwith to the Imperial Recorder.

2012: A year to celebrate our Fraternity and its Philanthropy

In 2012, we celebrate the 140th anniversary of the Shriners fraternity and the 90th anniversary of Shriners Hospitals for Children.

The Fraternity

One hundred forty years ago, the Ancient Arabic Order of the Nobles of the Mystic Shrine, or more familiarly, Shriners of North America (now Shriners International) was established. The new fraternity, designed to add fun and camaraderie to the Masonic experience, was born of discussions among a group of Masons who gathered regularly for lunch, and was formed and founded by two of those Masons - William J. "Billy" Florence and Walter M. Fleming, M.D.

Over time the fraternity flourished and expanded. Today, there are 195 chartered Temples, hundreds of thousands of members, and thousands of affiliated Clubs located throughout the world.

In 1922, the fraternity began its official philanthropic efforts, opening the first Shriners Hospital in Shreveport, La. Today, Shriners Hospitals for Children is a health care system with 22 facilities in three countries, and is recognized worldwide as a leader in specialized pediatric health care, innovative research and outstanding medical education opportunities.

This year, as we celebrate the fraternity's 140th year, we honor both the vision of the fraternity's founders and the continued dedication and commitment of the members to the ideals of brotherhood, camaraderie, family and service. We also acknowledge with gratitude their creation of Shriners Hospitals for Children to improve the lives of children. Given such a rewarding and generous past, the future of our beloved fraternity can only be something worthy and wonderful.

The Philanthropy

Shriners Hospitals for Children is celebrating its 90th anniversary this year.

After the first Shriners Hospitals for Children opened in Shreveport, La., in 1922, Shriners established hospitals in Honolulu, Minneapolis and San Francisco (relocated to Sacramento, Calif., in 1997) the following year. In 1924, the developing health care system expanded to Portland, Ore., St. Louis, and Spokane, Wash. By the end of the decade, there were 14 Shriners Hospitals for Children, including one in Canada.

The Mexico City location was added in 1945, and the remaining orthopaedic hospitals were added slowly between 1952 and 1985 - the latest one in Tampa, Fla.

The three hospitals originally dedicated specifically to pediatric burn care were added in the 1960s, and the Northern California hospital - the only one in the system offering care for all four, care disciplines - opened in 1997.

Today, the fraternity's philanthropic effort is a network of 22 pediatric specialty facilities in three countries, offering care for pediatric orthopaedic conditions, burns, spinal cord injuries and cleft lip and palate, regardless of the ability to pay.

Together, the fraternity and its philanthropy have improved the lives of nearly 1 million children.

We congratulate both organizations for their many achievements and look forward to what they will accomplish in the future.

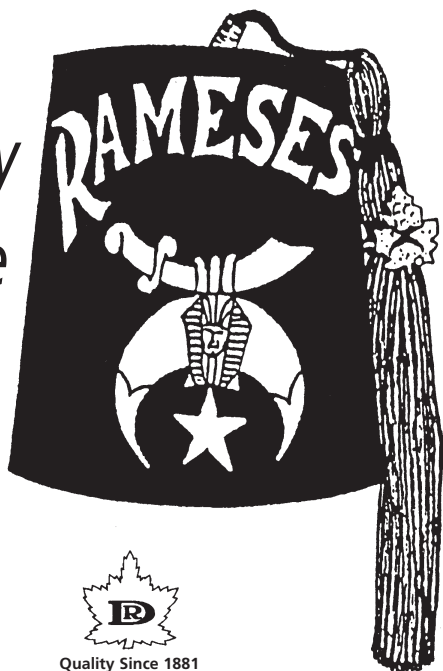
